| I propose to construct a wooden frame, second storey bedroom, on top of my rear extension. The exterior dimensions of the room extend 4meter away from the rear wall of the existing house and is 6meter wide. As there is a velux in the rear existing roof, I propose a flat roof on the extension which will then slope down towards the existing roof with the slope starting from above the edge of the existing house wall. I propose to clad the exterior in a wood effect plastic to match the existing colour of the house as this will last longer and is more sustainable. There will be one window on my drive side that will have obscure glazing 1m (h) 1.5m (w) and another 2 windows in the rear facing wall of the same size. Where the new slope on the extension meets the existing roof there will be a SIKA liquid plastics valley. The roof will use the existing drains on the site | | | | | | | |
