I write in response to your application to discharge the conditions pursuant to planning approval

Condition 6 (Bird and Bat Boxes) is partially discharged insofar that the submitted details are considered acceptable as follows:

The condition requires that the development be carried out in accordance with the approved details. Upon the development having been completed in strict accordance with the approved details this condition shall be considered fully discharged.

Condition 14 (Protected Species) requires the submission of a protected species mitigation license. Notwithstanding this, section 5.2.1, page 16, Annex B of the submitted bat survey dated June 2021 states that a Natural England licence will not be required in this instance as the proposed development would not impact upon any known bat roosts.

Accordingly, Condition 14 cannot be discharged and as such would require removal through a separate S73 application for removal / variation of a condition.

Right of Appeal

If you are aggrieved by the decision of your local planning authority to refuse permission for the proposed development or to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.

- · If you want to appeal against your local planning authority's decision then you must do so within 6 months of the date of this notice.
- · If this is a decision to refuse planning permission, or approve with conditions, a householder application, if you want to appeal against your local planning authority's decision then you must do so within 12 weeks of the date of this notice.
- · If this is a decision to refuse planning permission, or approve with conditions, a minor commercial application, if you want to appeal against your local planning authority's decision then you must do so within 12 weeks of the date of this notice.

authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order. If an enforcement notice is served relating to the same or substantially the same land and development as in your application and if you want to appeal against your local planning authority's decision on your application, then you must do so within: 28 days of the date of service of the enforcement notice, or within 6 months [12 weeks in the case of a householder appeal] of the date of this notice, whichever period expires earlier. In certain circumstances, a claim may be made against the local planning authority for compensation, where permission is refused or granted subject to conditions by the Secretary of State on appeal or on a reference of the application to him. Purchase Notices
