To construct a first floor with pitched roof over, above a single storey extension to the property that received Planning consent in 2015 (reference 3/2014/1102/P) forming an extra bedroom to the rear of the property. Extending the roof line 1.3 metres to the east with matching pitch and slate tile together with the removal of an existing chimney to allow the formation of a playroom/guest bedroom within the existing roof structure with a dormer window at the rear of the property. The roof structure will receive insulation forming a warm roof structure to comply with current Building Regulations and existing slate tiles will be re-fitted over new battens. Various internal partitions will be modified forming the proposed new layout.
