**Proposed Holiday Lodges at Fishes and Peggy Hill Farm, Henthorn Rd, Clitheroe.
Transport Statement**

Further to your recent instruction, I am pleased to provide a Transport Statement to support the planning application for the proposed holiday lodge development comprising 6 no holiday lodges with associated access road and parking.

The Site Location Plan is reproduced at **Annex 1**. The plans illustrating the proposals are included at **Annex 2**.

As part of the pre-planning application process, the Council has been consulted albeit that this was in relation to a holiday accommodation development of 2 lodges and 3 shepherds huts. Their response, dated 27th October 2020, is reproduced at **Annex 3**. Within the response the Council considered that:

“The access to the site is fairly narrow and the proposal would intensify the use of it by persons who are unfamiliar with the area.”

This statement seeks to assess the transport implications of the proposals, with specific reference to the issue raised, as set out below.

Existing Access

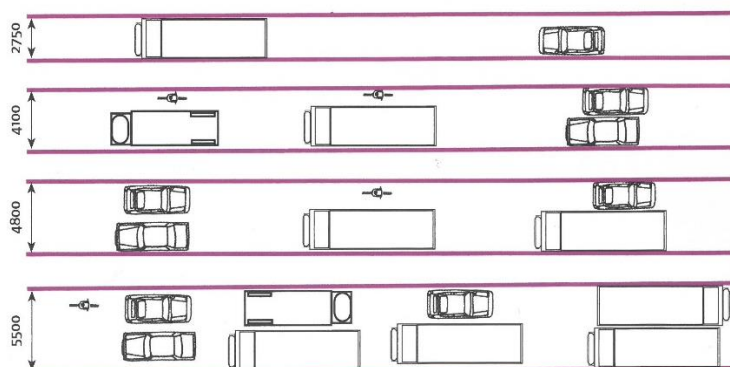
The existing access to site is via Henthorn Road from the centre of Clitheroe. Henthorn Road provides access to both the RVBC Clitheroe Household Waste Recycling Centre and the sewage treatment works some 400m north of the site. From this point it is understood that the road becomes ‘private’ as a vehicular access serving Fishes and Peggy Hill Farm and Shuttleworth Farm. It also forms part of the Ribble Way public footpath.

A measured survey of the 'private' section of Henthorn Road between the Recycling Centre and the Site Access was undertaken. The results of this survey are illustrated at **Annex 4**. The access road is generally between 3.4m and 4.1m in width, widening to between 5.9m to 10m at the passing places.

Photographs 1-6 illustrate the full length of the 'private' section of Henthorn Road in both directions between the Recycling Centre in the north to the Site Access in the south.

Manual for Streets (Figure 7.1) reproduced below, sets out the widths required to accommodate various vehicles.



As can be seen, whilst the access road is narrow in places, there are passing places at both ends (recycling centre and site access) and two intermediate passing places. As illustrated, there is inter-visibility between each passing place which is more than adequate for vehicles to wait in the unlikely event that they meet a vehicle travelling. In fact, whilst on site during the site visit only 1 vehicle was observed over a 2-hour period. This was a small HGV delivering to the farm.

With regards to pedestrians, there is clearly more than sufficient width along the full length of the access road for vehicles to pass pedestrians. Furthermore, there is additional verge width to accommodate both pedestrians and localised widening should this be considered necessary to provide additional passing places.

Intensification of existing Access Road

In order to quantify the existing use of the access road, a 7-day ATC speed and traffic volume survey was undertaken Tuesday 20th April 2021 to Monday 26th April 2021 (inclusive). The results of this survey are reproduced in **Annex 5**.

The results of the survey are summarised in **Table 1** below.

The traffic counts confirm the site observations that the access road is very lightly trafficked with just one movement in each direction every 12 minutes even in the busiest average hour. Vehicular speeds are also very low.

Reference to the the LCC MARIO website indicates that there have been no recorded accidents along this stretch of road within the last 5 years. This is also confirmed by the Applicant.

In light of the information presented above, it is clear that the existing access road is very lightly trafficked with low vehicle speeds. Accordingly, it is considered that conditions on the road are compatible with its function as a vehicular/pedestrian shared surface.

In terms of the potential intensification attributable to the proposed development, given the proposed holiday lodge use, it is generally accepted that these units result in low levels of trip generation, particularly in the traditional peak periods on the local highway network. Each unit would generally result in 2-4 trips per day however, given the accessible location of the site (see the walking and cycle isochrones at **Figures 3 and 4**) and the Ribble Way passing the site, it is likely that a significant proportion of these trips would not be made by car.

Even adopting a very robust approach that all trips will be car borne, the proposals would still only generate 12-24 trips per day. Clearly this would not be significant and would certainly not perceptibly affect existing conditions on Henthorn Road nor its existing exemplary safety record.

Construction Vehicles

The modest nature of the proposals is such that there would be very few construction vehicles required to visit the site and such movements would occur over a very short period of time. This, combined with the fact that Henthorn Road is very lightly trafficked (by all modes), means that there is very little probability that an existing user of the lane would meet a construction vehicle on the short section between the site and recycling centre.

Notwithstanding this, as demonstrated above, there is more than adequate provision of passing places along Henthorn Lane for a car to pass a construction HGV in any event.

Taking cognisance of this it is difficult to see how it could be concluded that the use of the existing access for occasional construction HGV traffic over a very short period could result a significant danger to the public. However, should the Council have concerns in this regard, then this could be dealt with through a Construction Traffic Management Plan (CTMP) and secured through a planning condition.

Conclusion

As set out above, it is clear that the proposals would result in very few additional traffic movements along Henthorn Road during both the construction and operational periods. In any event however, it has been demonstrated that there is sufficient provision along Henthorn Road (between the recycling centre and the site access) for vehicles to pass comfortably and that existing traffic flows and speeds are low.

As a consequence, any impacts on highway operation or safety along Henthorn Road attributable to the proposals, would be negligible. In fact, the evidence would suggest that '*safe and suitable access to the site can be achieved for all users*' (NPPF para 108 b.); and that there would not be '*an unacceptable impact on highway safety*' or '*severe residual cumulative impacts on the road network.*' (NPPF para 109). These are the relevant policy tests with regards to highways.

In summary, considering the information presented above, I feel that there should be no highways or transport reason why the current proposals should not be granted planning consent.

I trust that the above will satisfy your current requirements but please let me know should you require anything further.

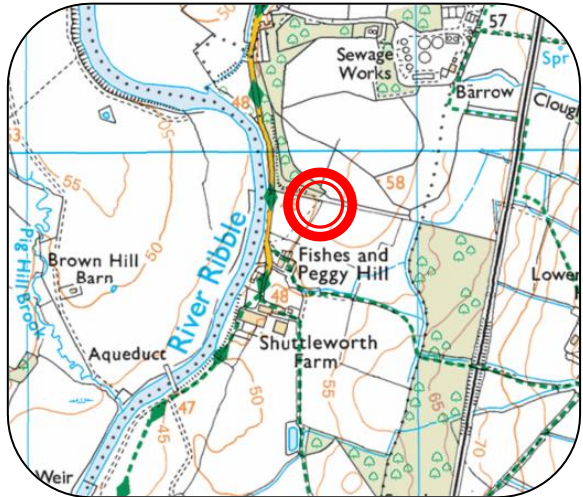

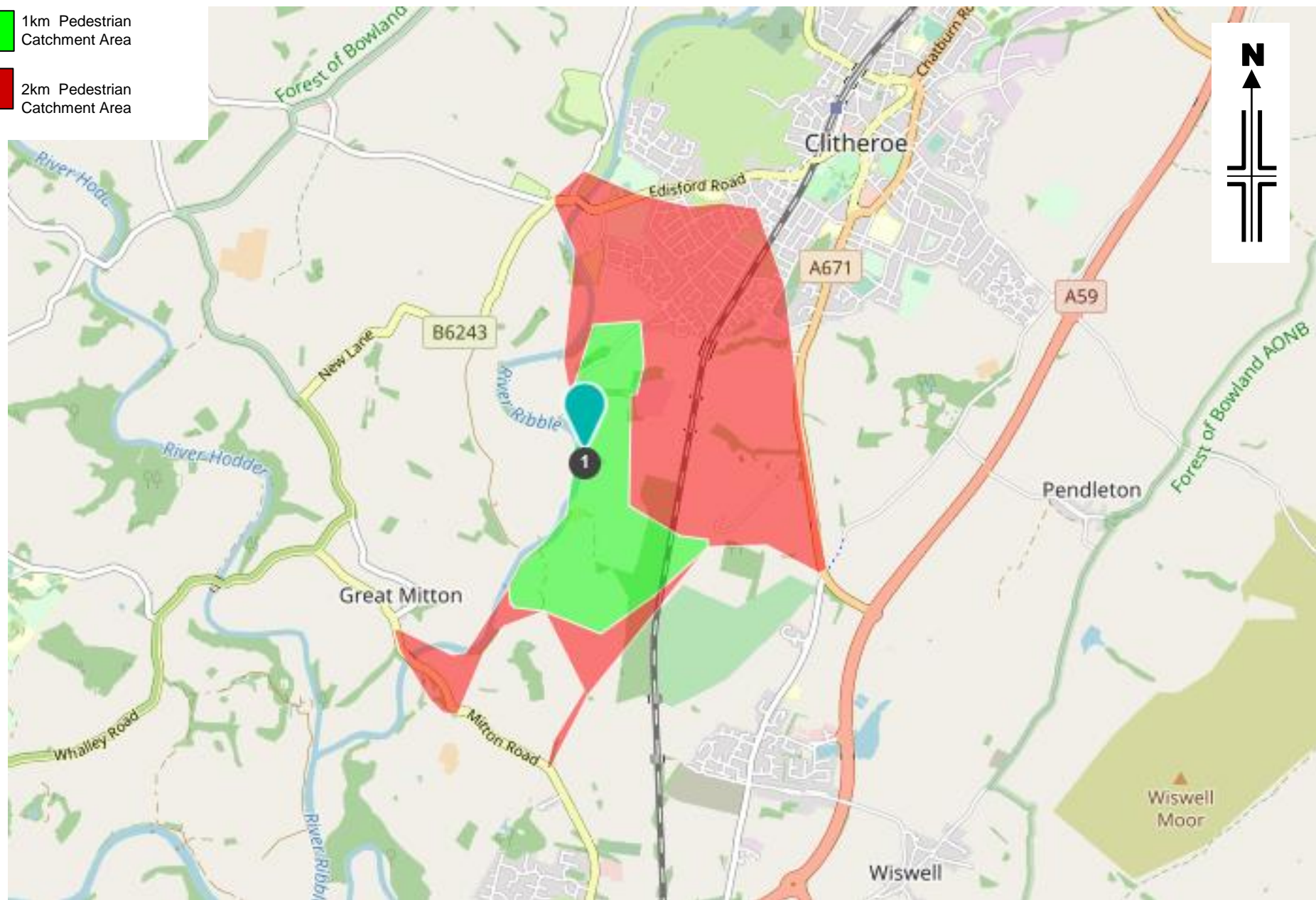

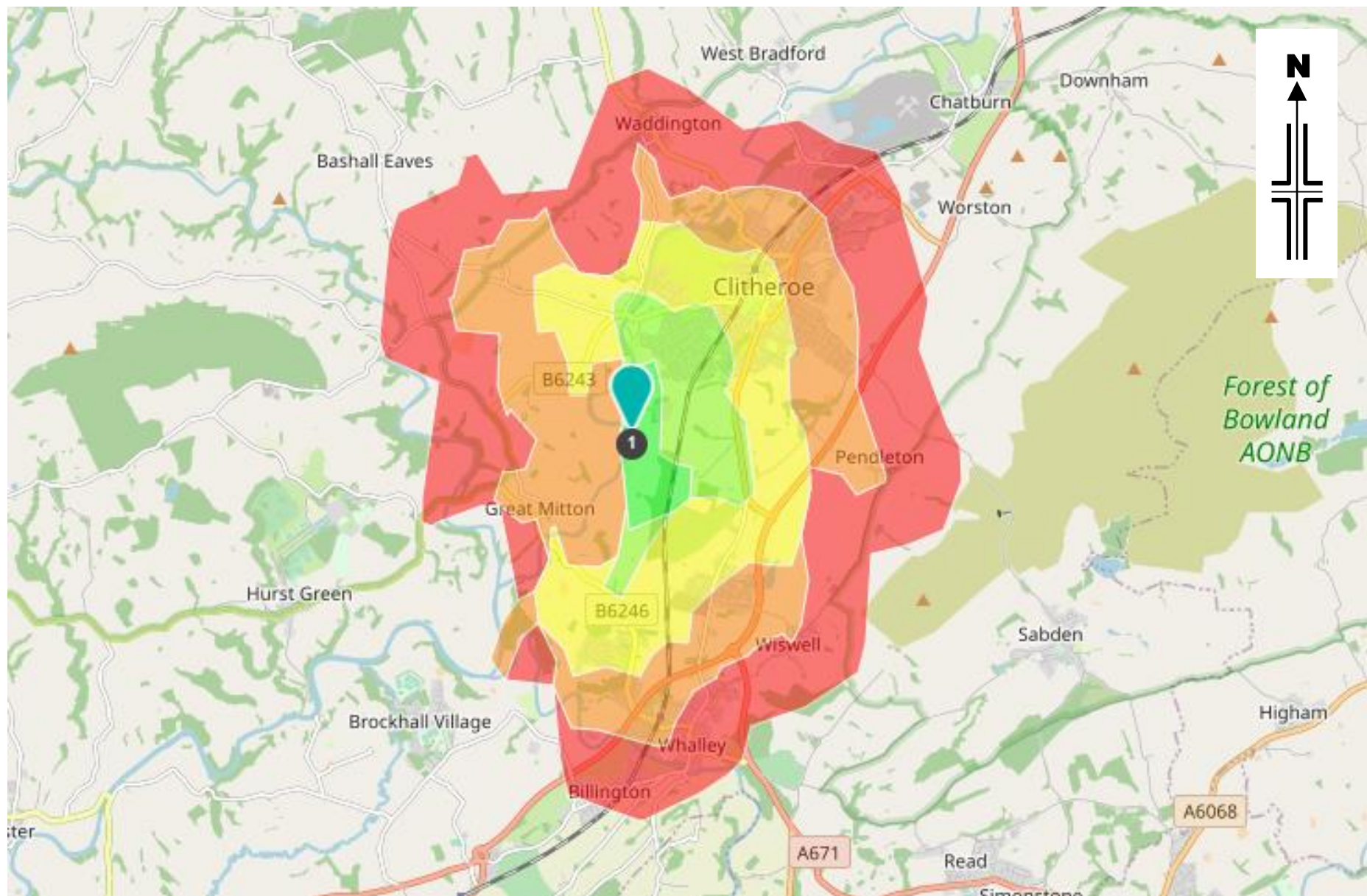




Site Location

Pre-Application Enquiry Response

Dear Andrew,

I write further to your submission of a request for pre-application advice at Fishes and Peggy Hill Farm on behalf of Mr Mark Ashworth. The enquiry seeks the Council's views on the construction of 5 holiday accommodation units in the form of 2 holiday lodges and 3 shepherds huts.

National Planning Policy Framework (NPPF)

Principle of Development:

The submission seeks advice with regards to the construction of holiday accommodation on land at Fishes and Peggy Hill Farm. The site is located on the edge of Clitheroe in open countryside.

Policy DMG2 of the core strategy seeks to direct development away from the open countryside except in certain limited circumstances on of which is where the development is for small scale tourism or recreational developments appropriate to a rural area.

Furthermore, policy DMB3 is supportive of development proposals that extend the range of tourism and visitor facilities in the borough providing the proposal does not conflict with other policies of this plan and it is physically well related to an existing main settlement or village, or to an existing group of buildings.

The proposal is for 5 modest holiday units. It will be located on a site that is bounded on two sides by the existing buildings at Peggy Hill Farm and Shuttleworth Farm and adjoins the River Ribble to the West. As such I consider that it accords with policies DMG2 and DMB3 and is acceptable in principle subject to an assessment of the other material considerations.

Design / Layout / Landscape:

The site is located in a fairly secluded location accessed via a narrow track. I do not consider that it will be highly prominent in long distance views. The materials and design proposed are rustic and it is considered that they will be in keeping with the surroundings and potentially would not have a harmful impact on the visual quality of the area. We will need to see details of any other external works such as alterations to the access, boundary treatments and formation of hardstanding areas as these could have an impact on the appearance of the area if not sensitively designed.

Ecology / Trees:

Details of any proposed tree removal will be required and measure proposed to protect any trees during construction. A landscaping scheme should be provided to ensure the development is suitably screened and to help it blend into the surroundings. With regards to protected species a preliminary ecological appraisal should be carried out to identify any species which may be adversely affected by the development.

Residential Amenity:

There are some residential properties other than the applicants in proximity to the proposal. However, the separation distance is as such that I do not feel that the proposal would have a harmful impact on residential amenity.

Highways:

LCC Highways would need to be consulted separately via their own chargeable pre-application enquiry service. The access to the site is fairly narrow and the proposal would intensify the use of it by persons who are unfamiliar with the area. I would recommend that you engage with LCCs pre-application service to gain their views on the proposal. We will also need to see how parking for the 5 units will be provided and any proposed hard surfacing etc that is required.

Flooding:

It is noted that part of the site within flood zones 2 and 3 being directly adjacent to the river; although you state that the land is higher and does not flood. The Environment Agency would seek to direct certain types of development away from areas at the highest risk of flooding. Therefore, a flood risk assessment will need to be undertaken. The should include proposed mitigation measures such as finished floor levels being above flood levels and an evacuation plan in case of a flood event to demonstrate that this is a safe development. It should also be demonstrated that the proposal will not increase flood risk elsewhere. The Lead Local Flood Authority also offer their own chargeable pre-application enquiry service which you may wish to engage with.

Other Matters:

Due to recent changes in planning legislation the Council must now seek the formal agreement of the applicant (or their agent) to impose pre-commencement conditions, should it be minded to grant planning permission.

Therefore, you may wish to consider providing a greater level of information at the outset for the Council to assess, in order to avoid the need for such conditions. A provisional validation checklist is provided below, however I'm sure you appreciate that requests for further technical information may be made by third party

consultees during the application which cannot necessarily be anticipated at this stage. The below link is to the Council's recently adopted Validation checklist.

Conclusion:

The proposal is considered, in my opinion, to be acceptable in principle in spatial planning terms. However, I do have concerns with regards to the location within the Flood Zones. Therefore, a positive recommendation on any subsequent planning application would be subject to an assessment of the other material planning considerations and the issues above being satisfactorily addressed.

Submission Requirements:

Should you proceed to submission of a formal application, based on the nature of the proposal/site constraints identified above, it is my opinion that the Local Planning Authority would require the following information to accompany such an application:

Plans

Planning statement

Design and access statement

Flood risk assessment

Ecological appraisal

Landscaping scheme

Transport statement

Please note this aforementioned required information may not be exhaustive and is provided on the basis of the level of information submitted. Failure to provide required information is likely to result in an application being made invalid until such information is received or potentially refused on the basis of insufficient information.

Please also be advised that Lancashire County Council provide a separate, chargeable pre-application service for highway related matters and drainage matters. 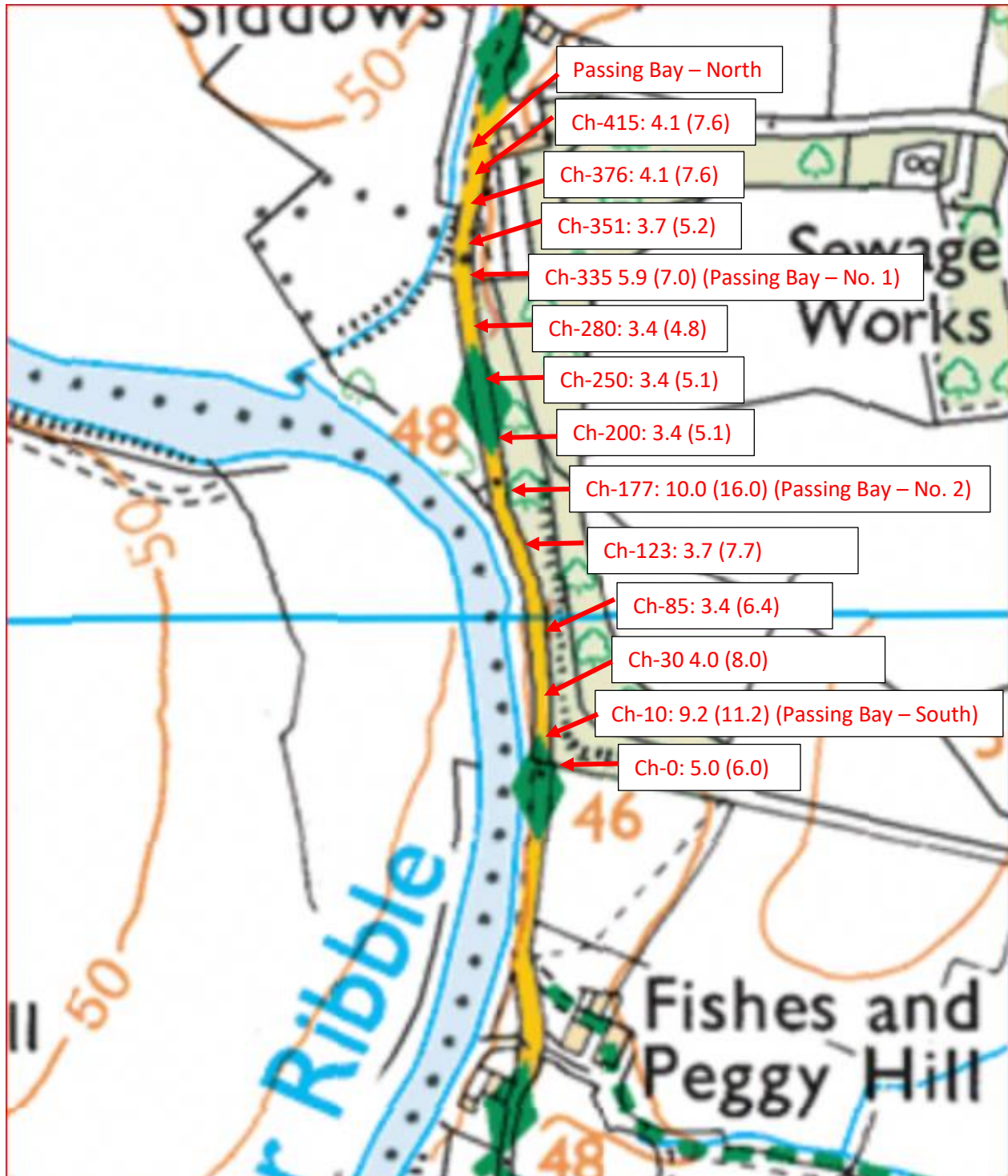
