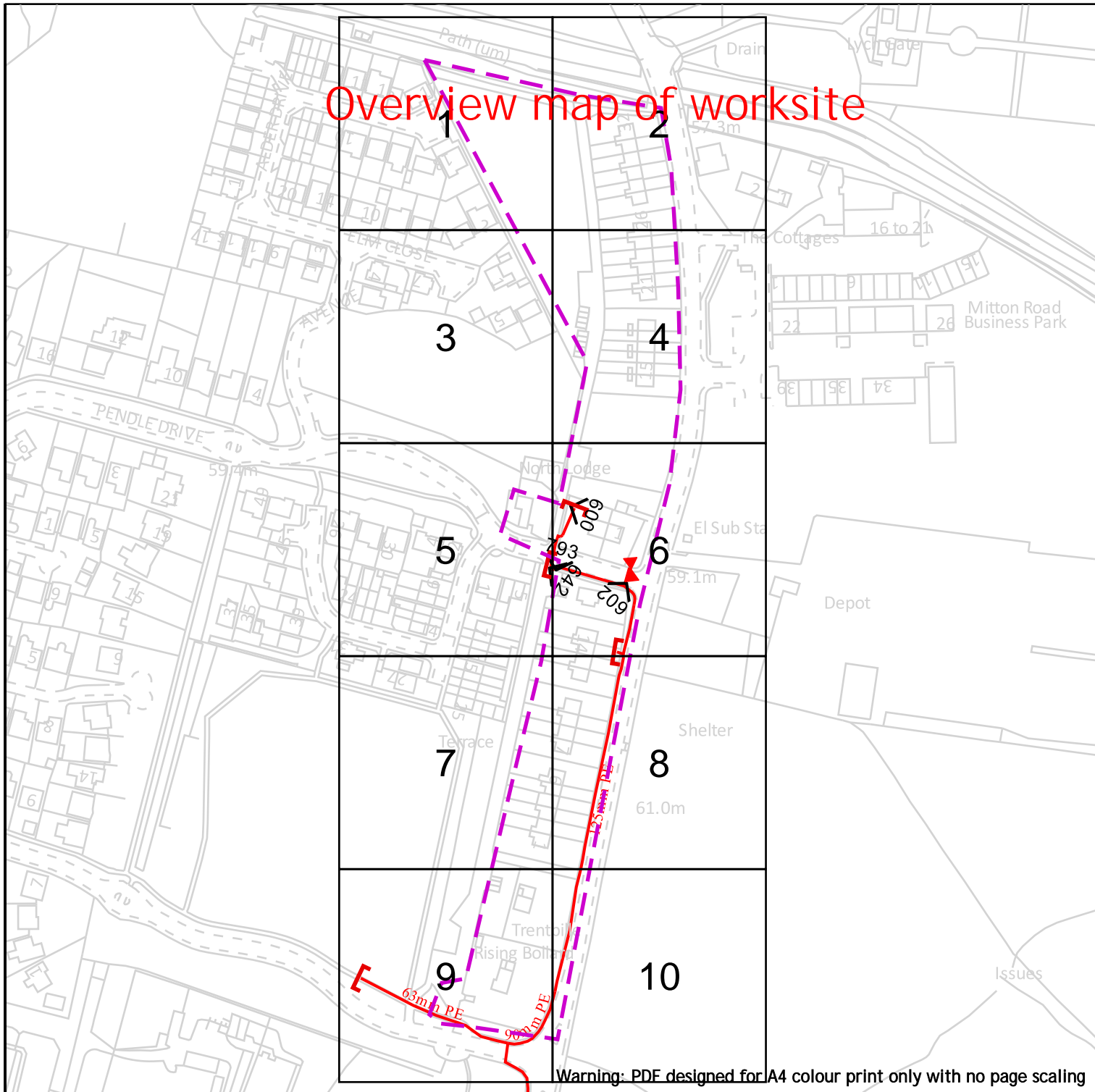


Overview map of worksite
