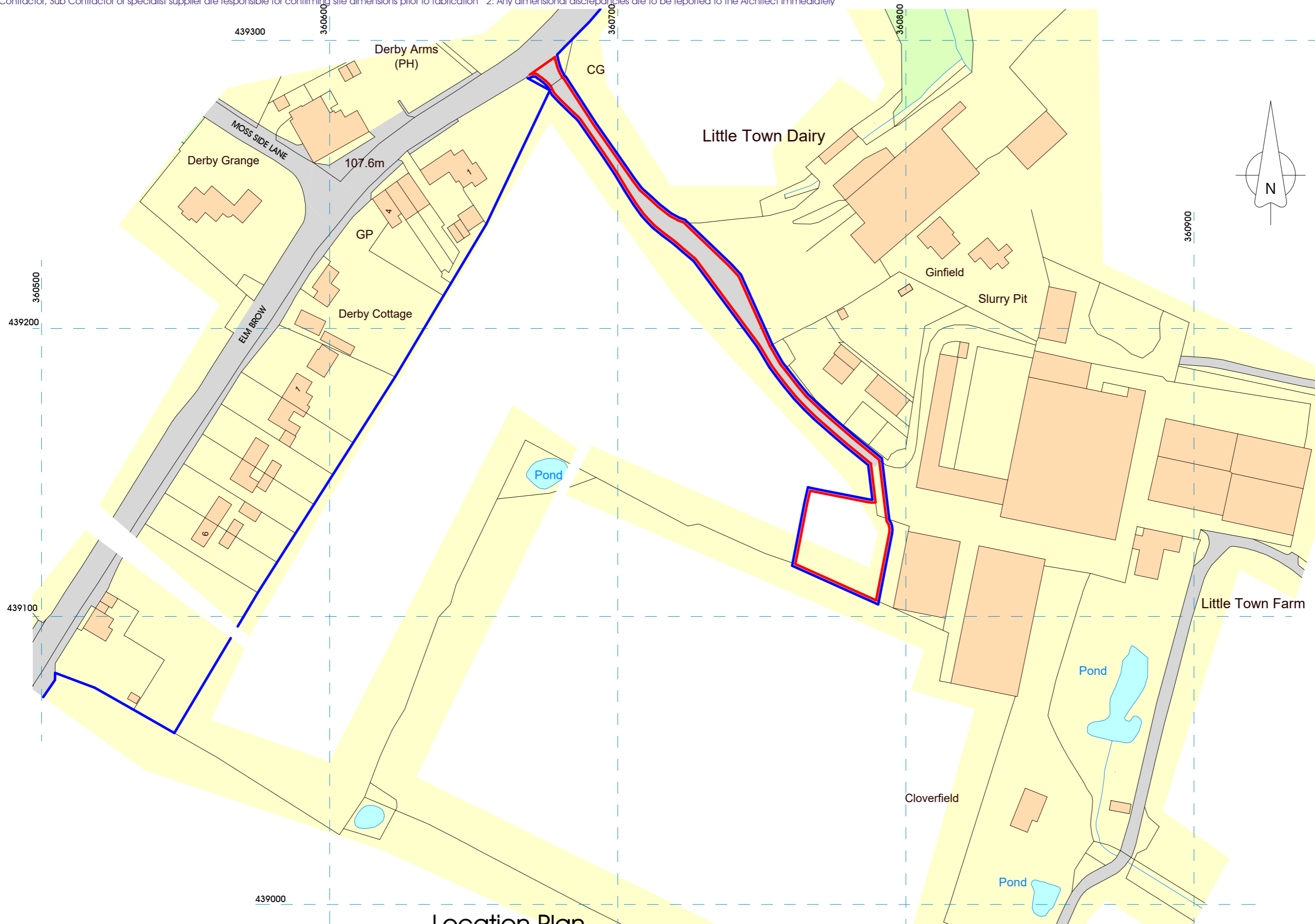

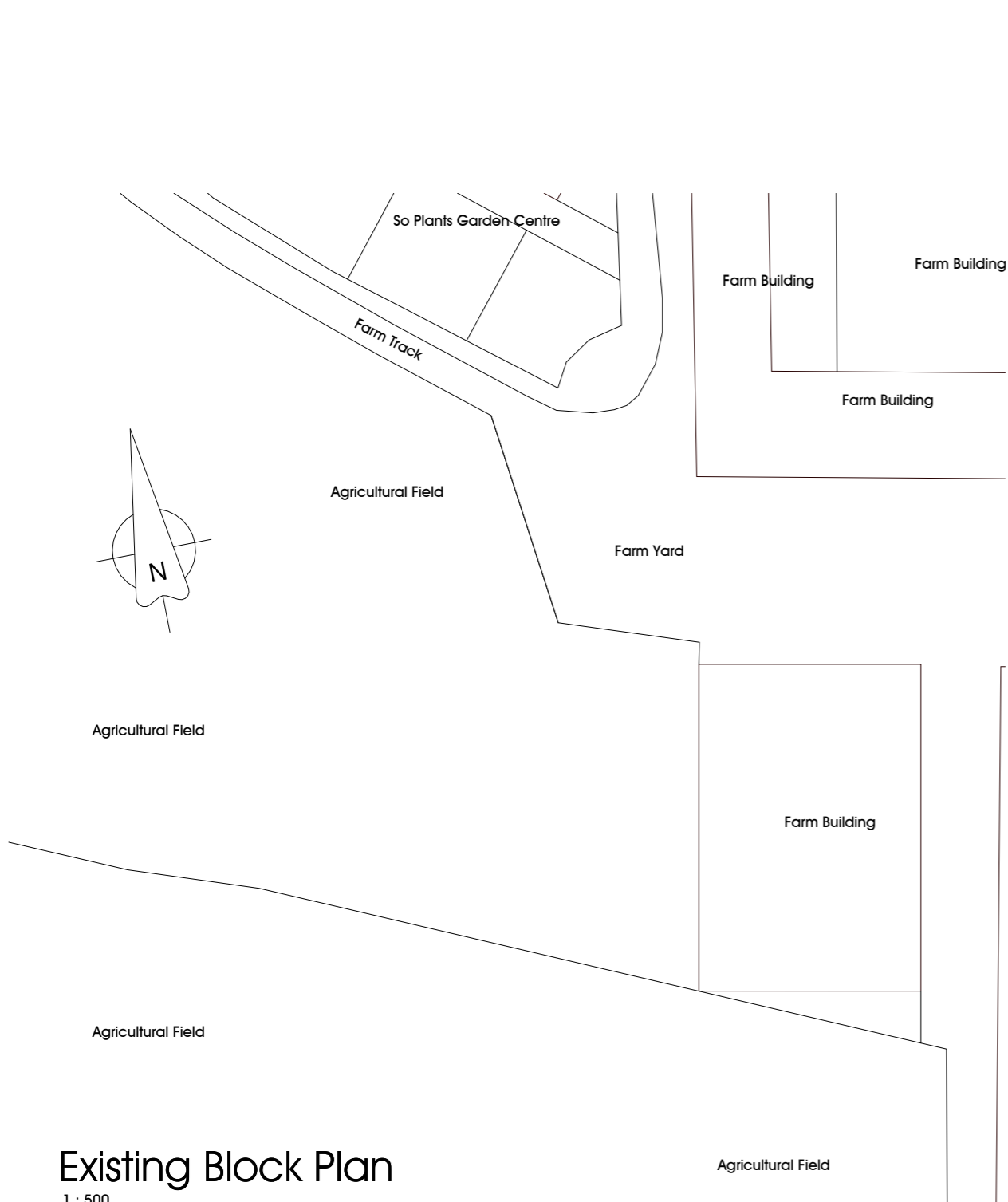

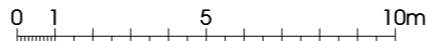
Existing Block Plan

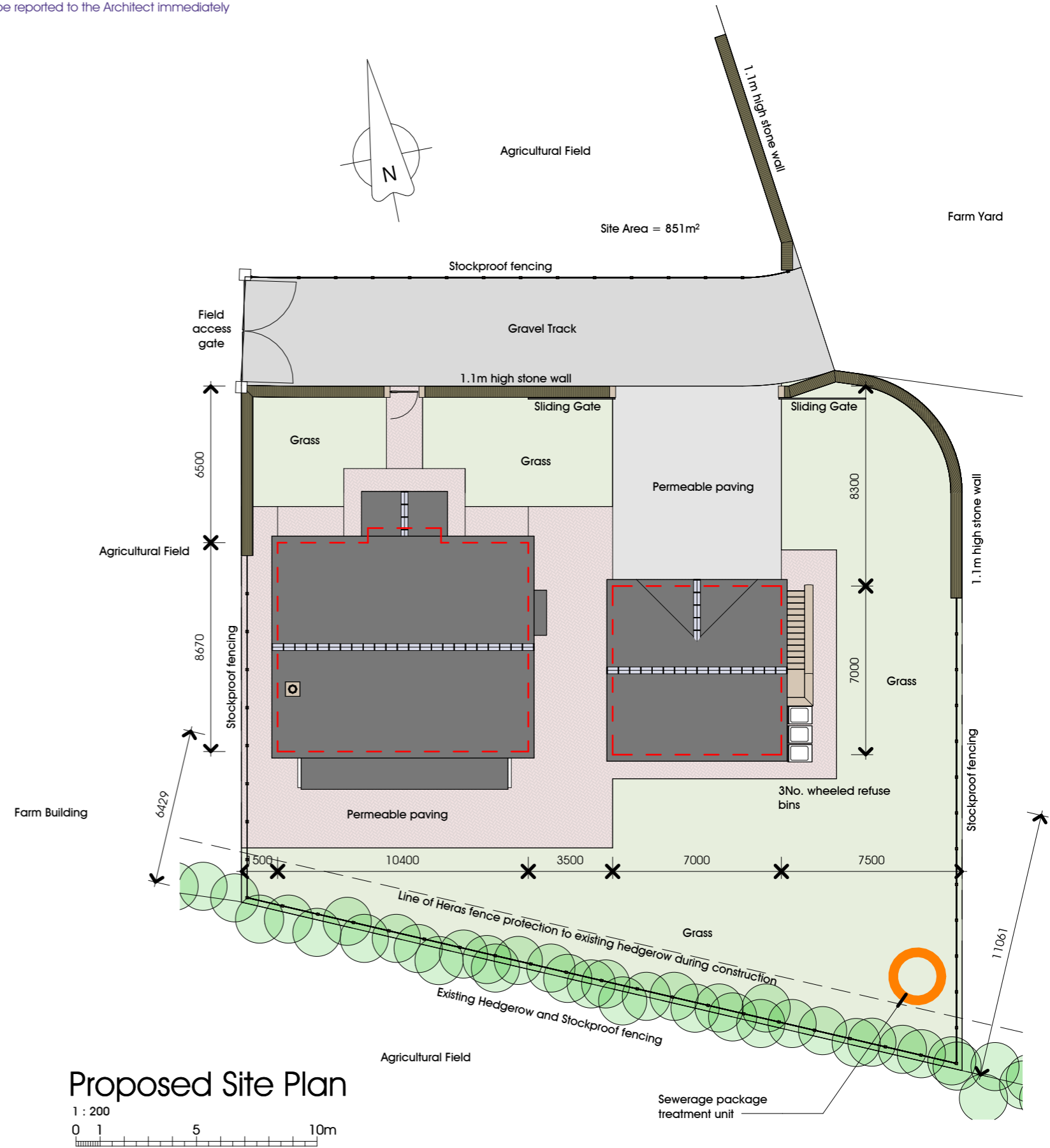
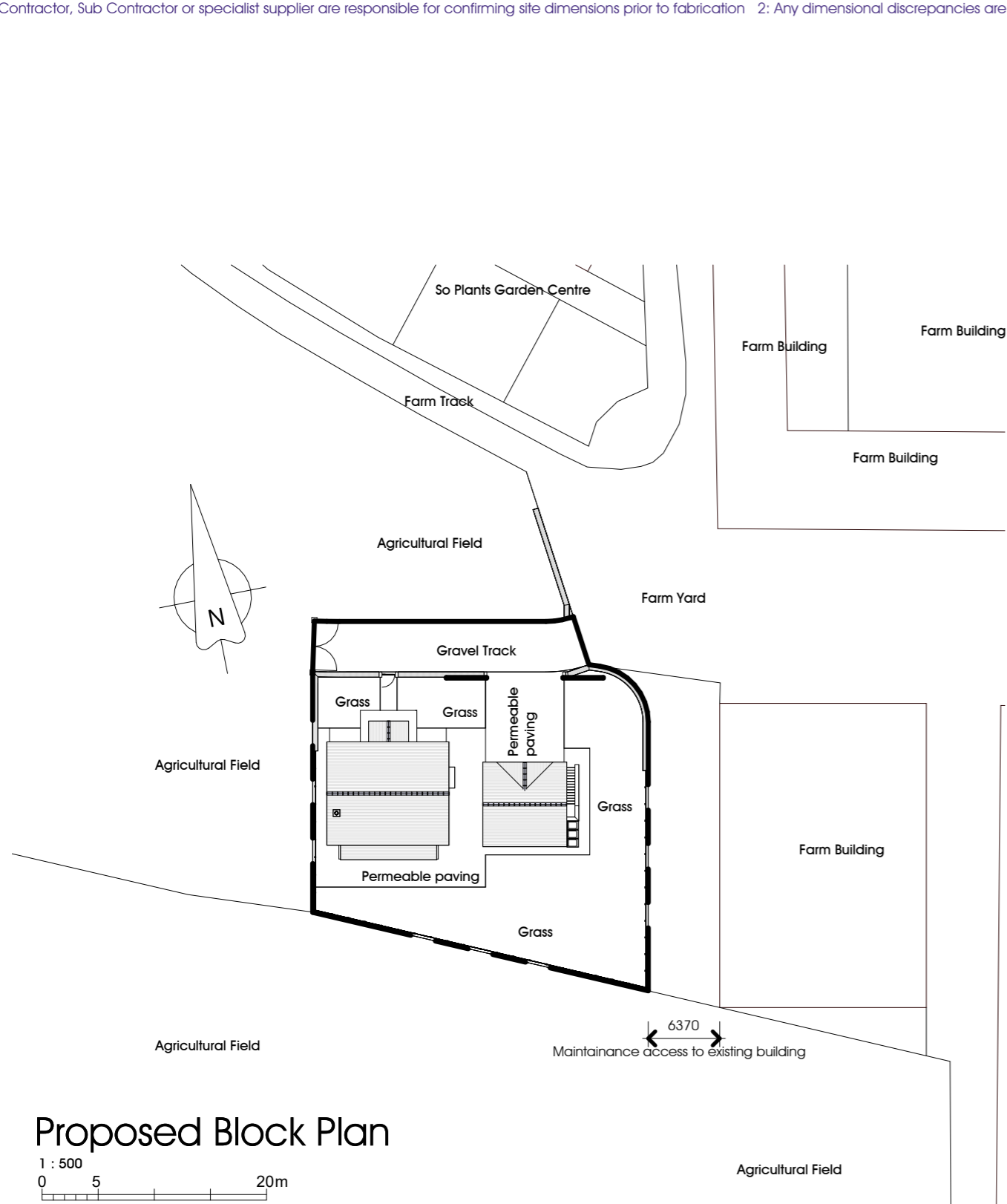
Existing Site Plan

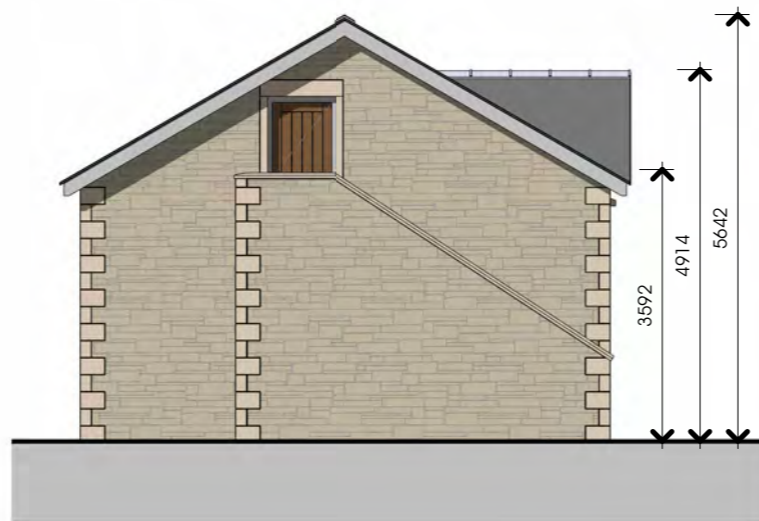


First Floor Plan

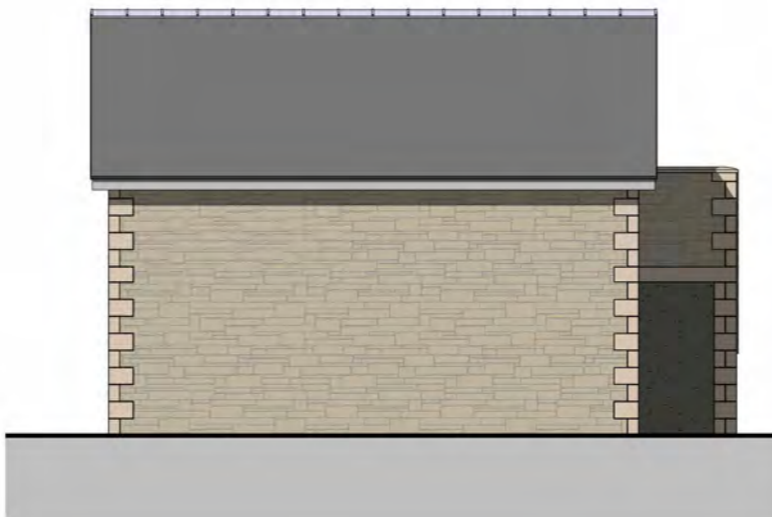
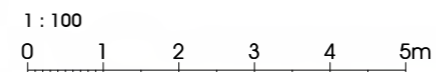


Ground Floor Plan
