My understanding is that that the Landowner Sustrains and Railway Paths Ltd have not been notified. There is a legal requirement for the Council to publish the notice for this application. I would like to know, where this notice has been published, was it published in the Clitheroe Advertiser? Is so on what date? How are people supposed to comment or object to application, if they don't know about them?		
In order to maintain the structure of the viaduct access is required, and this access is via the northern end of the viaduct. The Title registry LA885684 Section A4 grants access. With the ditch being dug this now restricts the access. The removal of the earth to create the ditch could add to the decay and degradation of the viaduct. The removal of the earth was to prevent trespass onto the Landowners land. have erected a 2m high fence, which stops anyone from crossing the viaduct onto the Caravan Parks land.		
The applicant in the application under materials has indicated that No materials have been added, yet the creation of the path means that tonnes of hardcore material has been added in order to create the path.		
Also the applicant indicates that no trees or bushes have been removed, by ticking no in the application, this is incorrect as there was trees and bushes, which google earth shows. The link is below.		

Therefore I would object to planning permission being granted.

I wish to object to the retrospective planning application numbered above.		
As someone who walks along the old railway embankment from odd that the walk ends at the old railway viaduct.		
The walk takes me along the pathway that was built and maintained by an exceptional group of volunteers who have completely transformed the area, over many years of hard work. I used to live on and my home overlooked the old railway track and I saw at first-hand what was being done by these volunteers.		
Throughout their time on the project, the landowner to open up the northern end of the viaduct and he has always refused. If these plans are passed, they would remove all possibility of the walk being opened up to connect with the route from Simonstone.
