T1&T2-Larch-Fell-2 x Larch trees are showing signs of root heave and leaning excessively (see attached photos)

Replacement trees numbering 170 have been planted in December 2022 to replace felled trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
