Historically the farmhouse was a smaller cottage with an adjoining stone barn. Approx 60 years ago, a section on the adjoining barn was converted to provide additional internal space for the house (Image 1, 1966). Approx 30 years ago, an extension at the rear of the property was added; in two phases, ground level initially, and the upper level was added shortly after (Image 2, 1990)

The remaining adjoining barn was converted for Independent residential use approx. 15 years ago. More recently the names of the dwellings have been changed, the original main farmhouse is now known as Laneside House (Grade II listed), and the barn conversion is named Laneside Farm.

Gardens have been gradually extended into the surrounding land over the past 100 years. Use of land is historically (and currently) predominantly for equestrian use.
