Please describe the proposed development, including any change of use:

**Renovation of detached outbuilding to Highcliffe Cottage:** Originally comprising toilet, utility/store, garage; there is no change of use, except the garage becoming a cycle lock-up: an ideal asset to Highcliffe Cottage – a future holiday let. Apart from reduced height, most of the north gable and front of the building, including the original low doorway stone lintel, will be conserved. The remainder demolished, reserving all random stone for re-building. A major concern is the accessibility of the roof from the garden. Having a duty of care to all visitors, safety railings are imperative; achievable with the proposed roof structure. Reducing the roof height by 0.7m will help ease the overbearing nature of the outbuilding to the cottage's kitchen/diner, which is 1m below ground level.  
*N.B. The garden's south retaining stone wall, damaged by roots, will be re-built and a fence re-instated, completing a safe/secure boundary to the garden.*

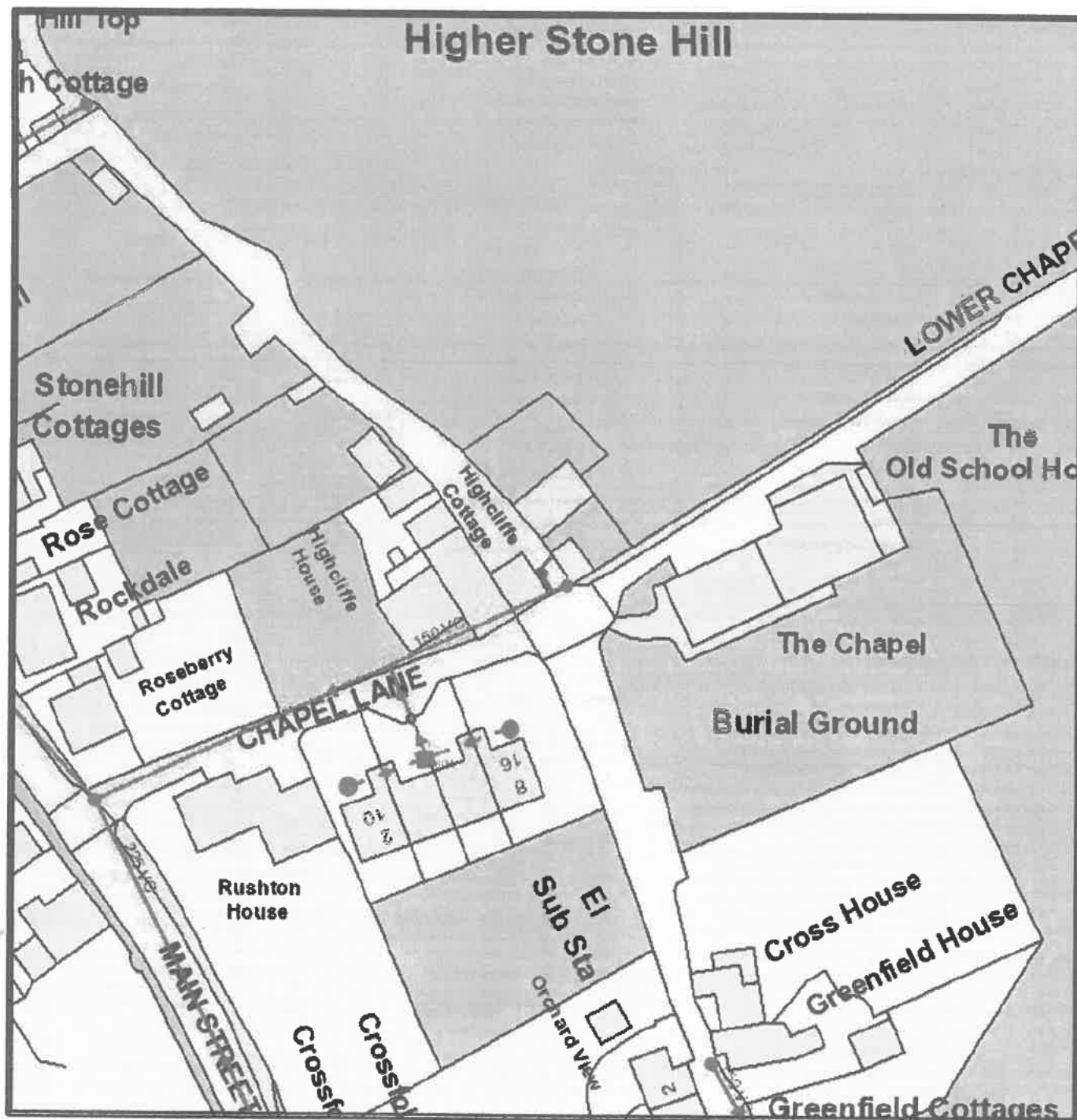
