Comments: As a resident of Lodge View I would like to strongly object to the felling of a Scots Pine and the cutting back of a willow tree without without the relevant permission and a consultation period. Both trees contributed greatly to the aesthetic and character of Lodge View, with its unique setting enhancing the row of 200 year old cottages. This border of trees and shrubs was a corridor for wildlife and birds; a Tawny Owl roosted in the Scots Pine every year and its call could be heard most evenings. In Spring it is usually alive with birdsong and nesting birds. The removal of these trees will impact the birds greatly this year, as it has impacted our enjoyment of the area. On returning home to find the Scots Pine felled, the tree surgeon told me that the Willow tree was coming down next. I informed him that Lodge view is in a conservation area but he continued to lop branches off the Willow knowing full well it was something he should not be doing. I can understand the owner wanting more light in his property, and I to have no objection to the trees being cut back, but he should have followed the proper procedures. This action amounts to nothing more than wanton vandalism which has resulted in a four meter totem pole and a hacked away Willow tree. I fear that this sort of behaviour could set a precedent in the area if not dealt with seriously and with consequences for these actions.
