The conclusion in the advice was:

As such and taking account of the above it is considered that the principle of the development, notwithstanding other development management considerations, for the change of use from that of a residential annexe to that of independent holiday accommodation would be in broad alignment with the aims and objectives of Key Statement EC3 and Policy DMB3 of the Ribble valley Core Strategy.

Further to the above, you will note that Policy DMB3 contains inherent criterion that are solely engaged when proposals are located within the Forest of Bowland AONB (sub-criterion 1 and 2), with the policy also requiring that proposals do not result in conflicts with other policies within the adopted development plan.

As such, in respect of matters of design, visual impact or highways, should a detailed proposal be presented that triggers or results in overriding conflict with Policy DMB3 or any other adopted development plan policies, then the general support offered by Policy DMB3 may be fully disengaged depending on the weight and significance of such conflict(s).
