T1 – Sycamore with advanced dieback in crown and suspected *Ustilina* in amongst buttresses. To fell.

T2 – Sycamore – to crown lift lateral branches to clear parking area.

T3 – Sycamore – Crown lift

T4 – Sycamore – to remove due to dieback of crown and location as overhangs public highway.

All trees, especially sycamore show historical evidence of soil level having been raised when landscaping.

T5 – Lime – To crown lift & deadwood

T6 – Lime – To crown lift & deadwood

T7 – Lime – To crown lift & deadwood

Will replace both trees where possible – they may have to be planted in the back garden as the surface where trees are being removed from isn't suitable.
