We are submitting this application in follow up to a previous one numbered 3/2019/0780 which was approved. The felling of the tree (Horse Chestnut) has not been completed to a satisfactory level and further felling is now required. This tree had been identified as diseased and required attention.

There is a second tree, also a Horse Chestnut, in close proximity (8 feet away) that we have been advised by our Tree Surgeon has the Honey Fungus disease and requires feeling also. It is our intention , subject to your approval being granted that this tree will; be taken down to circa 4ft above the ground.

Since we have acquired the property we have recently planted two new trees that will effectively replace the ones we are looking to remove.

The wood will be removed / used to support heating of the property and the site will be left in good order

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
