I am applying for dual use of the property so that I can hold private tuition classes between the hours of 4pm-8pm Monday to Thursday and 9am-11am on Saturdays in the name of Northern Sky Education Ltd. We will offer specialist dyslexia provision as well as support for students between KS2 and KS5 in English and maths. This will not alter the appearance of the property as all that is required is the addition of a table and chairs at the back of the shop. It does mean a slight extension to the opening hours as currently, the retail store has permission for use until 6pm. However, the presence of takeaways, bars and a tanning shop adjacent to the premises mean that this part of town is currently used by the public up to and beyond 8pm.
