Description

We are applying to have a full-height cabin in the top half of the garden. This would consist of a gym/bedroom, an office/ living room, and a toilet /shower room.

This is for three purposes:

1. To have a home office. I work from home as a church leader and have no office to meet people in.
2. To have a gym. This needs the building to be 2.7m in height as otherwise users of the cross trainer will hit their heads on the ceiling.
3. To have extra accommodation for our growing family. When family visit this needs to be large enough for parents and children.

It isn't appropriate to extend The Old Coach House: it would detract from its' character. The position chosen for the cabin preserves the view from the house.

The proposal for the cabin being 2.7m is not affected by proximity to the boundary, which is well over 2m away (14m away).

We considered other types of cabin, including log cabins and insulated sheds, but went for Modular Buildings "Opulence" Garden Room, which is 8.7m x 4.4m. The "SIP" method of construction is more resilient, better insulated and lower maintenance. These are similar to the buildings at the "Everything Retreat" which is just round the corner.

The best position for the cabin is roughly in the middle of the garden: this has the best view of Pendle Hill and the Ribble Valley and is far enough south to avoid the large cypress trees which would completely block the view. Higher up the garden loses the view of Pendle and is also further from the house.

The current footpath that goes through our garden would be obstructed by this building, so we are also applying to the Public Rights of Way section at Lancashire CC for this to be moved.
