

Comments: I have read through all documents and feel I need to add more depth to just what DMD is and what it means to our community.

DMD is located at the bottom end of Longridge, away from Berry Lane, the central hub of Longridge. Being some distance away from there, the local community was serviced by the old Public House, the Duke William. It was a great pub, with regular live music and events, but sadly, that closed several years ago and has since been turned into housing leaving the bottom end of Longridge without a place to meet, build relationships, and support each other.

Since opening in 2020, DMD has reignited the local community, not only those who live in the area but also those who travel from further afield to purchase goods and secure their interior design expertise, amazing for Longridge's economy and our brand, showing that Longridge is a lovely place to visit and spend their money. DMD is an advocate of small businesses and often has flyers and advises its customers of other places to shop, eat, and drink in central Longridge.

On a personal note

DMD has reignited a lost area of Longridge. It has become a community hub where people meet and buy amazing things for their homes rather than shopping online and have made strong friendships. The age range is wide, with many older folk enjoying a shop and drink and having a face-to-face conversation, often receiving ongoing support from others. At the other end of the scale, younger folk also visit DMD again to make purchases or with their parents shopping and having a drink. It is wonderful to see our young folk feeling that sense of community — priceless, as these are our adults and decision-makers of the future — the ones that will keep Longridge a beautiful and prosperous place.

We are at a time where mental health and well-being are front of mind and I cannot recount the number of conversations I have had, personally with DMD's customers, on how DMD has either been a lifeline, stopped the loneliness, or created friendships. I have also taken advantage of the premises to hold business meetings and have held and supported several charity events there.

Whilst opening hours are minimal, closed Monday and Tuesday (in recognition of the church and events), only open till 8 pm Wednesday through Saturday, and at the earlier time of 5 pm on a Sunday DMD is an absolute gem making a huge difference to many. Whilst I can still shop there, I miss being able to take time out, sit with friends, reach out to those who need support, and feel part of a community that cares.
