Removal of existing staircase and installation of new staircase with alterations to the first floor structure to suit proposed position of new staircase. Existing windows to be replaced with new painted timber windows. Existing front door to be replaced with new vertically boarded and painted timber door. Existing kitchen patio doors to be replaced with new painted timber stable door with top glazed panels. New sanitaryware and fixtures to replace existing modern sanitaryware and fixtures to the existing bathroom. New kitchen units to replace existing modern kitchen units to the existing kitchen. New ground floor WC formed in stud partitions, with sliding door, and installation of new counter tops and sink, all to ground floor entrance hall.
