The Principal Contractor will be responsible for carrying out the following:


a) Obtaining all necessary under/above ground service information from statutory authorities to ascertain the existence of any live services, prior to starting any work on site.
b) Carefully CAT scanning all necessary areas of the site and for hand excavating to safely determine any existing underground services prior to starting any work on site.
c) Carefully re-direct/ protect any existing underground services during the course of works ensuring that their existence and position are clearly marked at all times.
d) Promptly inform the Client and Building Inspector of any unknown live services found.

EXISTING SERVICES

Services that need to be altered, modified, adjusted, or re-sited to facilitate the new building works, should be carried out by a suitably qualified and experience specialists or registered competent persons, tested and appropriate certification issued where necessary. Existing services should be located, altered/ modified/ relocated as necessary, including sealing up, capping off, disconnecting, removing redundant services where required.




EXISTING EAST ELEVATION




EXISTING WEST ELEVATION
