Good Afternoon,

With a prior notification we assess the application against national legislation. It may well be that the criteria has changed since any previous applications for livestock buildings at the site.

The proposed building was less than 400m from the curtilage of the nearest neighbouring dwelling and consequently does not line-up with the national legislation to be classed as permitted development and therefore prior approval is required. The decision with a prior isn't subjective, its essentially a tick box exercise against legislation.

The applicant would need to apply for the proposed building under a full application, rather than a prior notification. The application you are referencing at Lime House was a full application, not prior notification.
