- No raised decking, verandas / balconies > 300mm
- No form of encroachment over boundaries,

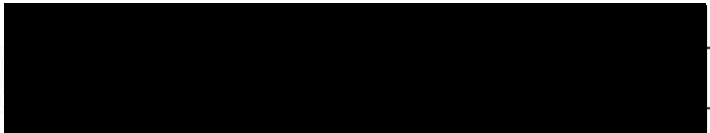
