Comments: I would strongly advise that planning permission is denied for this request. The area is an AONB, meaning it is visually beautiful and this would bring the area down with tarmac being used and vehicles being parked on the edge of the preservation area, disrupting the wildlife in the area. It is not in keeping with the area.

I would like to point out the health and safety risks of removing the pavement. Pedestrians will have to cross the drive way to get to and from the bus stop. Vehicles, including farm vehicles, constantly speed up the street. There is also ample parking available on the road near Shaw Terrace, as a single occupant of the house why is such a large driveway required?

The application stating vehicles regularly pass slowly is totally false, as you can see from the parish council minutes, vehicle speeds are a major concern for the villagers. It is outside of the parameters set by the LCC and I'd suggest their acceptance is reviewed. Manoeuvring on and off the drive will impact on the vehicles using Main Street, it is reasonably foreseeable that incidents will occur.

Comments: I would highly recommend the application be refused on the below grounds:

An application made in 2013 (3/2013/0378) was refused due to harming the character of the village and setting of listed buildings. This will irreparably change the character of the conservation area of Grindleton, that the property lies within. Therefore the same logic should apply again and application must be refused.

The owners of the property must have been well aware that parking is on-street when they purchased the property. Removal of existing stone wall will change the aesthetics of the pretty village, not have low visual impact as stated in the application, this is one of many false statements within the application.

Relocation of street lighting may cause dark areas on the footpath and is a major health and safety concern as the village houses many elderly residents and is right next to a bus stop. This will regularly disrupt the bus services on an already busy main road.

Vehicles reversing to and from the drive will cause a hazard to other road users, which includes farm vehicles and HGV's, and an incident is reasonable foreseeable. The splay is shorter than required and the speed limit is 30mph, which from parish council complaints is regularly exceeded. The statement "traffic is likely to be travelling slowly" is based on what ground? This statement should not be considered as it is not factual.

Finally the flora and fauna in the gardens off Shaw Terrace is a hive of activity for birds and insects and to replace some of this with tarmac and then vehicle emissions of vehicles using the drive would ruin this.

Please consider my views and refuse the application.
