This planning application is to replace 23 of 45 wooden windows in a phased operation owing to the constraints of funding; the remaining 22 windows will be replaced, at a later date, when funding permits.

It is intended that the replacement windows will match the existing windows on a "like-for-like" basis, i.e. in terms of colour, composition and appearance but with the exception that double glazing will replace the current, single-glazed windows to prevent/reduce heat loss from the building.

The intention of replacing the windows on a "like for like" basis is to ensure there is no discernible difference in the architectural appearance of the building and to meet RVBC's requirements for a building in a Conservation Area.

The building is adjacent to Lowergate (West elevation) and Highfield Road (South elevation) and with intervening houses, remote from Wilkin Square (East elevation). The North elevation is adjacent to houses on Lowergate.

The building has three floors; two floors (the ground and 1st floors) are used as places of worship and the latter also accommodates class rooms for childrens' religious education. The second floor is vacant and unused. An extension, used as washing facilities for prayers and for toilets, has been added to eastern end of the building. A car park is adjacent to the extension with access from Wilkin Square. A fence separates this car park from a larger one with its access from Bayley Fold.
