### Description

This application is to renew and extend the consent for a temporary building, Hodder House, originally granted permission 5/06/2019 (Application no. 3/2019/0335). The temporary building comprises of a single storey classroom extension to the pre-prep school known as Hodder House within the Stonyhurst College Estate. (Previous Application no.: 3/2019/0335, granted consent 5/06/2019). The extension provides two classroom spaces, WC facilities and a cloakroom. The applicant voluntarily seek temporary planning permission for an additional period of up to five years. The applicant plans to replace the temporary structure with something more permanent in the future. This is set out within the original Design and Access Statement. The timescales have been delayed from those originally intended due to the operational and financial impacts of COVID and inflation. The temporary accommodation is essential to enable continued sustainable business operations of the College. The applicant voluntarily seeks temporary planning permission for an additional period of three years.

The existing site comprises of external play space, an access ramp and a tarmac access road. The site adjoins the existing Hodder House building that is in use as a pre-prep school. Hodder House comprises of an original listed curtilage structure of the Grade II listed St Mary's Hall and subsequent later extensions to the NW and SE with neither addition of historic significance per the assessment set out in the Conservation Management Plan. No works are proposed to the original curtilage structure and connection to the temporary building is via a later addition.
