Horse chestnut tree approx 35 feet tall, crown reduction of 15 feet putting the tree back to its original size when I moved in to the property 18 years ago, allowing in poor weather conditions TV signal to get through, allowing more light on rear garden and gardens of adjoining properties, crown lifting of 6 feet as unable to safely maintain ground under and surrounding the tree.

I have approached a number of arboricultural specialists but non seem to want to do a report

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
