Due to Levels from 123m AOD to 117m AOD [West->East] & Electricity North West Engineering works burying 1,100 KVA affecting boundaries. Retaining walls need to have been used. Trees could not be planted on boundary with large level changes. Same number/type of Bird/Bat boxes used in line with the plan approved under application 3/2016/0984 save only for the manufacturer and are colour coded in keeping with the House rather than Grey Concrete colour. Location, style, mounting and quantities are all the same as approved details. There is no net loss to Habitat
