Looking back at what you have submitted and based on the proposed site plan your application description also needs to include change of use of land from agriculture to outdoor commercial storage as well as replacement of existing roof covering and existing cladding.

Because of the change in building appearance we need existing and proposed elevations and roof plan as well as existing and proposed floor plans all with dimensions shown.

Because of the alterations we'd need a structural survey to provide the building is capable of conversion/ re-use.

The application states 'industrial storage' – I am not sure what this means but if it would generate noise then a noise assessment would be needed.

Whilst not a validation requirement a planning statement to explain the building background and proposed use would be beneficial.
