The tree us in my back garden and I think it is a firn tree my garden is very small and the tree is much to big for the space it has been planted at some point and growing higher and thicker the bad weather us making this tree sway bad and I am really concerned if this tree breaks or any large branches snap then it will do serious damage to my home or myself if I am in the gsrdenit is not a suitable tree for the surrounding it has been placed please can you help me by either removing the tree fully or cutting the tree back at the top to stop it getting higher and thin the branches out also this tree is causing problems with the neigh our who is joined to my home she has said roots from this tree have came through to her property and lifting flags in her garden making it unsafe if she slips I am more than happy to plant another tree a smaller one which I will have planted if it is needed I do not want to chop down a healthy tree but this tree is going to become a serious problem which already at the height it is the tree is swaying very bad and as I have said the tree is way to big for my garden and directly in line with my home if the worse did happen and the tree snapped in bad weather or branches came away also for my safety while I am in the garden please can clitheroe council help me as I can not afford to have this done private if I am aloud and I am registered disabled and can not do the work myself I rent my ho.e through jigsaw homes but they have told me it is my problem yo deal with because they do not do work in the garden
