Tree to be removed: We propose to remove the large Cedar tree indicated on the submitted plans. This tree is in a very crowded area, is non-native and is impacting the nearby Yew trees which we wish to retain and improve. There are also large trees nearby on the adjacent properties which contribute to the overcrowding in this area.

Trees to be pruned/maintained: The lower branches of the three Yew trees indicated on the submitted plans are encroaching on the carriageway below the minimum clearance required of 2.5m. We propose to trim some of the lower branches to clear the carriageway to the regulation height.
