Retrospective application for the construction of a decking and ramp to rear

Raised decking area with ramp to allow level access to rear of property (as per Occupational Therapy recommendations). The decking is adjacent to the newly completed single storey extension and is the full width of the house- in the main, occupying the footprint of the former raised flagged patio.

A Certificate of Lawfulness request has been rejected due to the fact that the decking projects more than 4m from the original dwelling wall. The decked area projects 3.74m from the newly constructed single storey extension- and the ramp projects a further 1.15m. The decking is necessary to

- a) provide level access into the property
- b) provide feasible access and an adequate platform for the ramp.

Every effort has been made to ensure that the new construction is less than 0.3m above the surrounding ground level- and this has largely been achieved.

The ramp has been constructed using non-slip decking boards and meets a small flagged ramp down to the lawned garden and accesses the flagged path to the side of the property.

The decking is not visible from the road- and is not easily visible from neighbour's property.

Pictures of the 'in process' decking and ramp have been provided to RVBC Planning as part of the Certificate of Lawfulness application
