Amendments Summary

When the application was originally submitted an exemption from BNG was claimed for two reasons, firstly less than 25 m2 of development was affected, and secondly the development is a self & custom build proposal. The application has now been amended so that only a self & custom build exemption is requested. A completed unilateral agreement has been provided to confirm the development will be self & custom build. The submitted plans have been tweaked to make other minor amendments, and the application forms and Planning Statement have been revised to reflect the BNG change. The application has therefore been resubmitted via the planning portal.
