#### 1. Site Overview

The property is located within the Hurst Green Conservation Area, where all tree works are subject to notification under Section 211 of the Town and Country Planning Act 1990. The garden area at the rear of the property has been left unmanaged for some time and is in need of remedial works to ensure safety, enhance amenity value, and improve light and space for future management.

## 2. Tree Survey Schedule

Tree Ref Species Height (m) Condition Works Proposed Reason

- T1 Ash (Fraxinus excelsior) Approx. 18 Poor suffering from Ash Dieback Fell to main stem Tree is showing significant dieback; removal required for safety
- G1 Group of approx. 15 Beech (Fagus sylvatica) 3 10 Fair to Good Selective thinning To open up and manage overgrown back garden; improve access, light and visibility
- 3. Justification for Works
- T1 (Ash): The tree is suffering from Ash Dieback (Hymenoscyphus fraxineus), showing signs of canopy dieback and structural weakness. Due to its size and proximity to the garden, removal to the main stem is recommended for safety.
- G1 (Beech Group): The group of small beech trees has been unmanaged and is encroaching on usable garden space. Selective removal and thinning will allow light into the area, reduce competition, and create opportunities for future planting and maintenance.

### 4. Assessment of Impact

The proposed works are considered necessary and proportionate. Removal of the diseased Ash will mitigate the risk of failure and hazard. Thinning the beech group will enhance long-term amenity and usability of the garden space. These works will not result in a significant negative impact on the character of the Conservation Area and are part of responsible land and tree management.

### 5. Method of Works

All tree works will be carried out by qualified and insured arborists in accordance with BS3998:2010 - Tree Work - Recommendations.

Care will be taken to avoid damage to surrounding trees, structures, and habitats.

All arisings will be responsibly removed or processed on site as agreed.

## 6. Planning Notes

The site lies within the Hurst Green Conservation Area.

A formal Section 211 notice has been or will be submitted to the Local Planning Authority.

No trees are currently known to be subject to a Tree Preservation Order (TPO).

  - o showing the approximate distance between the application tree(s) and buildings
