The bathroom exists within an extended part of the house, outside of the characteristic original building & contains no original features or character. This is a superficial 'like for like' renovation which will bring the design of the bathroom in keeping with the character of the house. The current bathroom installation is very modern whereas the proposed design is more traditional and sympathetic to the era the property was built in. No structural changes are being made, there will be no change to existing pipework. Following advice from HEAG304 Historic England Guidance Note (p54) modern bathroom fittings are of no historic value and therefore LBC is not needed for their removal & replacement.
