Identification of Tree(s) and Description of Works

Tree outside 5 Somerset Ave. Identified as Tree T018 in Gary Marden's report. Tree is a mature 18m tall lime tree with a life expectancy of 40+ years. The tree is the tallest on the road and I'm concerned that it will be blown over should we see high summer winds. This is because three adjacent trees of similar age and height have been blown over in previous storms and I would like the tree to be crowned to reduce the chance of it falling onto the road or even my house in high winds.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
