The tree in question is the Sycamore in the front garden of 8, Blackburn Rd, which is within 2mtrs. of the front door and pictured on the front page of the report.
We are seeking permission to have the tree felled, as recommended in the attached report, carried out by Bowland Tree Consultancy Services. As detailed, the tree has been badly damaged, but is also in extremely close proximity to the house, and is in danger of encroaching upon the public pathway.
We would welcome advice on a suitable replacement tree for the available space.
