Reason for works: Abatement of nuisance.

T171: Oak

Minor pruning where canopy extends over pavement and road to maintain statutory clearance of 2.4m over pavement and 5.2m over the road.

All below are within G1:

Where the woodland edge species are extending beyond the railing pruning back to the boundary. Affected trees include:

G1A on tree location plan. Opposite 18 Sheepfold Cres 2 x elder

T3 on tree location plan. Opposite 24 Sheepfold Cres 1 x hawthorn

Minor crown lift/lateral reduction works:

T5 on tree location plan. Opposite 29 Sheepfold Cres – Early mature oak. Crown lift to 4m over road by lateral reduction of lowest branches.

T4 on tree location plan. Opposite 22 Sheepfold Cres – Early mature oak – Lateral reduction of 2m where extending towards property.

T1 on tree location plan. Rear of 15 Sheepfold Cres – Larch – Lateral reduction to create 2m clearance with property.

T2 on tree location plan. Opposite 28 Sheepfold Cres – Larch – Lateral reduction to create 2m clearance with property.

All above works are to be achieved by pruning of tertiary and higher order branches only (no pruning on main stem). Natural target pruning to be observed at an appropriate union. No pruning wound greater than 30mm diameter to be made.

All works will result in negligible loss of live crown mass (less than 5% of leafing material).

Works identified to T169 Ash are previously approved and do not form part of this application.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
