Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We live within the conservation area of Ribchester so designated for its Architectural and Historical interest. The rear garden to our terraced cottage is very small measuring approximately 5m square. The previous owners had the garden covered in plastic artificial grass and in one corner (shown on the attached sketch) is an ornamental cherry tree which we wish to remove. There are compelling reasons to remove the tree quite apart from our aims to convert the garden back to a more authentic cottage garden.

The Cherry tree has become overgrown for the site. It is snagging overhead telecoms and power lines dangerously and its shallow lateral roots extend above ground covering 25% or more of the available planting area.

As well as planting bushes, shrubs and flowers we will be replacing the Cherry tree with a slower growing specimen perhaps an Acer or something similar. We will be guided by the nursery who will be supplying us.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
