Works as follows to 4 number mature oak trees T13 to T16 as listed in the arboricultural report requiring:

- * balanced tree crowning to reduce the branch massing specifically near ground level
- *soiling and seeding to the root protection zone with shade resistant grass

to make a workable rear garden. These are listed to be retained in the planning consent 3/2024/0115 17th May 2024 condition 11 and TPO dated 16th February 2022.

 - adding other relevant features on the site (e.g. greenhouse, paths)
