Details of the pre-application advice received

Principle of Development:

The single-storey extension is acceptable in principle, subject to planning considerations.

Impact on Conservation Area:

The proposed materials (stone, render, roof tiles) will match the existing building and surroundings. The extension is located on the less prominent side of the building and won't affect key views or the character of the Conservation Area. It is unlikely to detract from the area's historic or architectural significance.

Residential Amenity:

The extension will be close to a neighbouring residential property but will not cause significant overshadowing, loss of outlook, or privacy impacts because of existing site conditions and lack of windows on the neighbour's side.

Visual Amenity:

The extension is modest in size (3m by 8m) with a lean-to roof that matches existing elements, ensuring it appears subordinate and visually integrated.

Conclusion:

The proposal is unlikely to cause significant harm to the Conservation Area, residential amenity, or visual appearance and would likely be supported on submission.
