Details of the pre-application advice received

Having looked at historic mapping for the farmstead the barn building in question appears to be shown on the 1890s OS Map and sited within what we would likely class as the curtilage of Crane Wood Farmhouse which is Grade II Listed. On this basis, our thoughts are that the barn would fall within the realm of a curtilage listed structure and as such Listed Building Consent would be required to replace the roof of the barn and to carry out repair works to the masonry as proposed. In addition, the replacement of the existing sheet roof with a slate roof would amount to a material change in the character and appearance of the barn building therefore a full planning application would also need to be submitted in order to carry out the proposed works.
