Proposed Change of Use from C3 Dwellinghouse to C2 Children's Residential Care Home (Solo Occupancy)

This application seeks full planning permission for the change of use of the existing single residential dwelling (Class C3) to a children's care home (Class C2) for the accommodation of one looked-after child. The proposed care setting will be operated by a registered children's home provider and will offer 24-hour care and support in a stable, nurturing domestic environment.

The child will live at the property on a long-term basis, with two staff members present at all times. One staff member will sleep overnight to replicate a traditional household setting. No external alterations to the building or its curtilage are proposed. The operation of the home will remain domestic in scale and character, with limited vehicle movements, no on-site meetings, and very few visitors beyond statutory services (e.g. social workers).

The proposal has been carefully designed to ensure that the use remains low-impact, sensitive to its residential setting, and fully compatible with the character of the area. The property is located in a quiet, low-crime neighbourhood and has been selected specifically for its suitability to support a child's wellbeing and integration into the community.
