## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Trees at rear of 1 Browgate. Tree number 1, Alder, good condition, leans over garage, reduce lower limbs over garage. Tree number 2, Ash, poor condition, pruning required. Tree number 3, Ash poor condition, ash back, some dead wood. Tree number 4, Alder, good condition leans over garage, possible minor aesthetic reduction over garage. Trees 1-4 have a lot of ivy on them. Tree 2 has broken limbs hanging up in the crown and two excessively long lower limbs over the garden which could also fall. Pruning work is needed to remove these limbs to reduce the risk of limb loss into the garden. Tree 3 is deteriorating but at present does not appear to pose an imminent threat to the garden area. Tree 4 leans over the garden but appears stable, pruning would be for aesthetic or nuisance reasons only.

Trees at rear of 5 Browgate. Tree number 5 good condition but much canopy over garden, possible aesthetic reduction over garden. Tree 5 is a sycamore. Tree number 6, Sycamore, good condition but much canopy over garden possible aesthetic reduction over garden. Tree number 7 good condition, preliminary management. N/A

Trees at rear of 1, Browgate. Trees numbers 1, 2, and 4, require pruning back to boundary line and dead, dangerous and damaged branches pruned back to main trunk.

Trees at rear of 5, Browgate. Trees numbers 5, and 6, require pruning back to boundary line and dead, dangerous and damaged branches pruned back to main trunk.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
