TREES WERE INSPECTED BY DAVID HEWITT ON TUESDAY, 9TH SEPTEMBER

T1. Beech (with Ganoderma applanatum): Fell/remove

T2. Beech: Crown reduction by 20-25% 2-3m via a thinning process, Main focus on reducing height of lateral stem which matches the leading stem for height.

T3. Red oak: Crown reduction by 20-25% 2-3m working mainly in the top third of the tree.

T4. Horse chestnut: Crown reduction 20-25% 2-3m working mainly on reducing the height to match the neighbouring trees.

T2, T3, and T4 were reduced in 2020 by ourselves. APPLICATION NO: 3/2020/0776. The work we are now applying for is to revisit and manage the regenerative growth.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
