Consequently, the proposed development would impact less than 25 square metres of onsite habitat that has a biodiversity value no greater than zero, thereby meeting Condition 2 of Section 4 of The Biodiversity Gain Requirements (Exemptions) Regulations 2024. The proposed development is therefore exempt from biodiversity net gain requirements and planning conditions under the de minimis rule of Section 4 of The Biodiversity Gain Requirements (Exemptions) Regulations 2024.

Summary conclusion as follows:

To conclude, full planning permission and listed building consent would be required for the proposed development. The proposed development would likely result in less than substantial harm to the designated heritage assets, however this would be at the lower end of less than substantial harm. Further information is required to fully assess the proposal including the Landscape and Visual Impact Assessment/Appraisal and Heritage Impact Assessment to fully assess the impact on the designated heritage assets and to fully assess the visual impact and any harm to the Forest of Bowland National Landscape.

As such, if an application were to be submitted in its current form, the proposal would fail to meet the requirements of Key Statement EN5 and Policy DME4 of the Ribble Valley Core Strategy, Sections 16 and 66 of the Planning (Listed Buildings and Conservation Areas) Act 1990 (as amended by s.58B of the Levelling-up and Regeneration Act 2023) and the National Planning Policy Framework.

A balance must be made between the benefit of adapting the buildings to provide renewable energy and reduce emissions and the harm that would arise to the designated heritage assets and the designated Forest of Bowland National Landscape. This would need to be fully assessed at the application stage, taking into consideration the further information required with a submission and following that work being undertaken, locating the solar panels in areas that would have the least impact visually and impact on the designated heritage assets.
