Removal of 1 x Horse chestnut tree to ground level

I will replace the tree with either 1 x lime or 1 x sycamore or 1 x oak tree, the size will be 16-18cm diameter, approximately 140 - 170 cm high

As per the tree assessment carried out on the 14/11/2024 by L & L Tree Services it was noted that the Horse chestnut tree will need observing and may need removal. The tree has further deteriorated and in January, 2025 a lot of large branches came down in high winds on the 24/01/2025. Photographs attached. Fortunately no damage was caused to property or persons.

The horse chestnut tree is T24 of TPO map 7-19-3-93 1988 Woodfold Park Mellor. The coordinates of the chestnut tree (T24) are 6375 2947

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
