E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

To fell the Oak tree T1 within the front garden to ground level and replant towards the northern corner of the front garden.

On recent inspection the tree was observed to be heavily stressed / strained with a thin canopy, minimal annual shoot extensions and a chlorotic appearance. There was die back at branch extremities and a level of defoliation. The tree has been recently cleaned through but it is apparent that die back / production of dead wood continues. No fungal fruiting bodies were observed on the tree or around the base within reasonable vicinity.

7. Identification Of Tree(s) And Description Of Works continued ...

The reason for decline is not obvious but is believed to be due to construction activities some 30 years previously. It is understood that during construction of the site levels had to be increased to provide bridging over an existing feature in close proximity. These level increases appear to have involved forming bankings from the highway down into gardens, all that would have encroached into the expected root protection area of the tree. The stem of the tree also appears to have been partially buried, no root buttresses are visible, the stem goes straight into the ground. The neighbouring garage has been constructed within the expected root protection area and it is questionable if this was either designed or constructed in accordance with current guidelines.

From all such observations and understandings it is considered that the root zone of the tree has been severely compromised and whilst it has taken many years, the tree is in an advanced state of decline due to root loss, damage and possible infection.

It is not considered that any reasonable courses of action can be taken to improve the root zone of the tree due to both the extent of burial and long term damage and that it has minimal safe useful life expectancy due to the proximity of third parties / properties and as such removal and replanting is the only prudent course of action.

Replanting is proposed with 1No. Hornbeam - *Carpinus betulus*, selected standard planted towards the northern corner of the site at a reasonable distance from the Oak stump and on the banking at an acceptable distance from adjacent structures.
