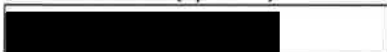

6. Discharge Of Condition

Condition No6: Our intention is to install single pane casement windows that are top hung, outward opening, double glazed, aluminium framed and anthracite in colour as per the approved planning application. The external porch door will be solid oak with single glazed panel as per the below.



Condition No5:

Walling, door/ window surrounds – these are sandstone heads and cills and original sandstone.

Roofing/ridge – Original Welsh slates and ridges have been reused.

Rainwater goods – Cast iron effect gutters and downpipe in black, the gutter is hung on rise and fall gutter brackets, with no fascia board. Plastic guttering and downpipe were originally fitted.
