6. Condition(s) - Removal

Please state why you wish the condition(s) to be removed or changed:

Stairs to the upper parking area (plan "A200 Rev C") could not be constructed due to extensive groundworks by United Utilities in 2020/21 when they had to repair a rising sewer main which runs up the steep bank behind the annex. United Utilities had to build a large 20 metre retaining wall (over 12 feet high) and had to dig back into the bank to access and repair the pipe. The slope became too steep for the planned steps plus any piling and construction of new steps in that area could compromise those repairs.

Due to topography (steep slopes on all sides) and to avoid the rising sewer main (United Utilities repairs) the only option to gain access to the annex from upper parking area is where the steps are located now ... see drawing "A200 Rev D".
