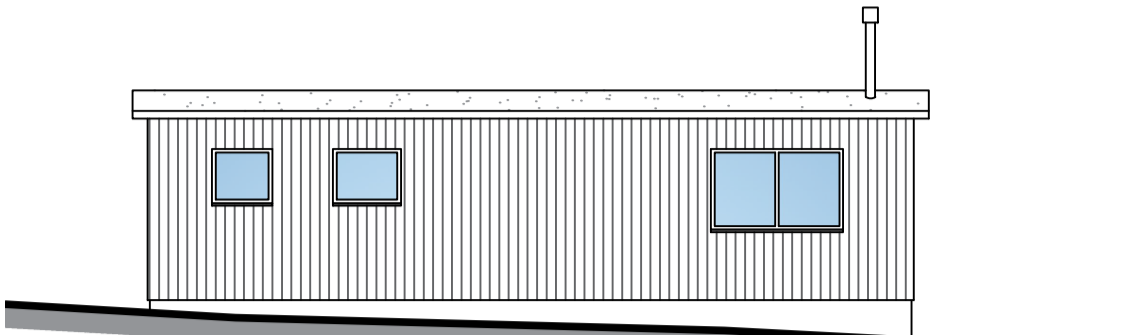

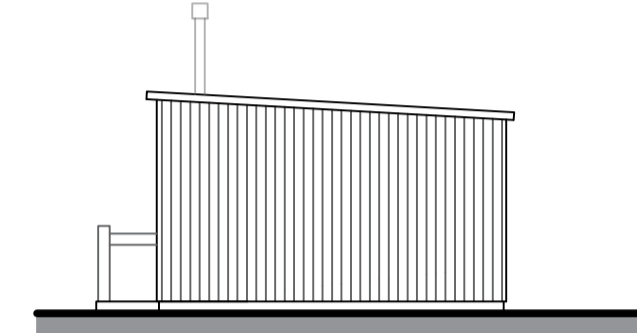
Proposed Ground Floor Plan

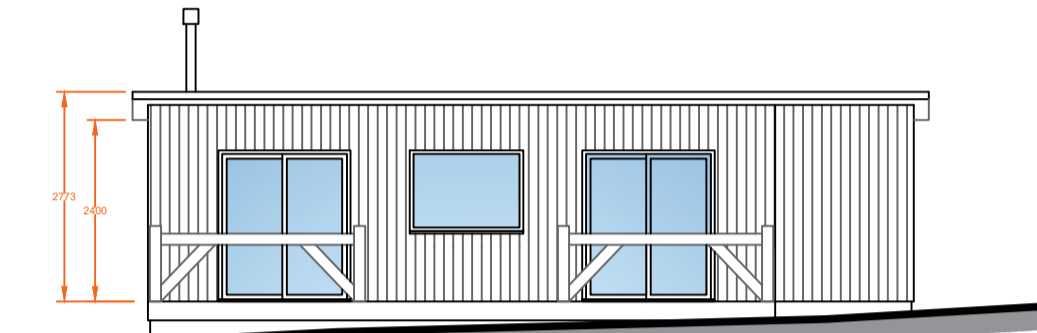
Proposed East Elevation

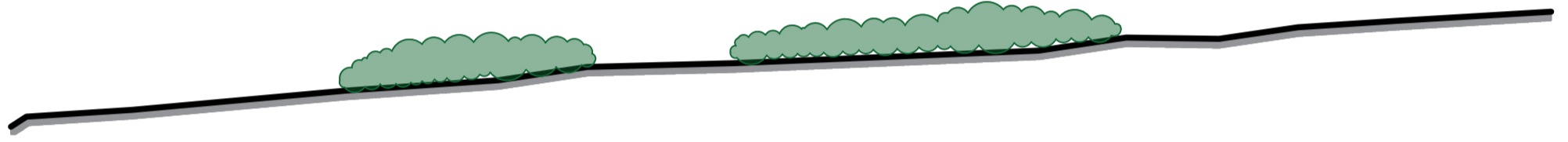
Proposed South Elevation

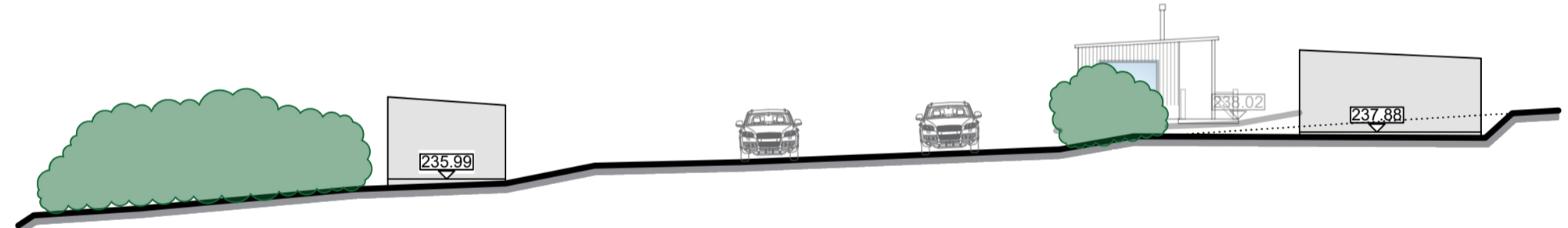
Proposed West Elevation

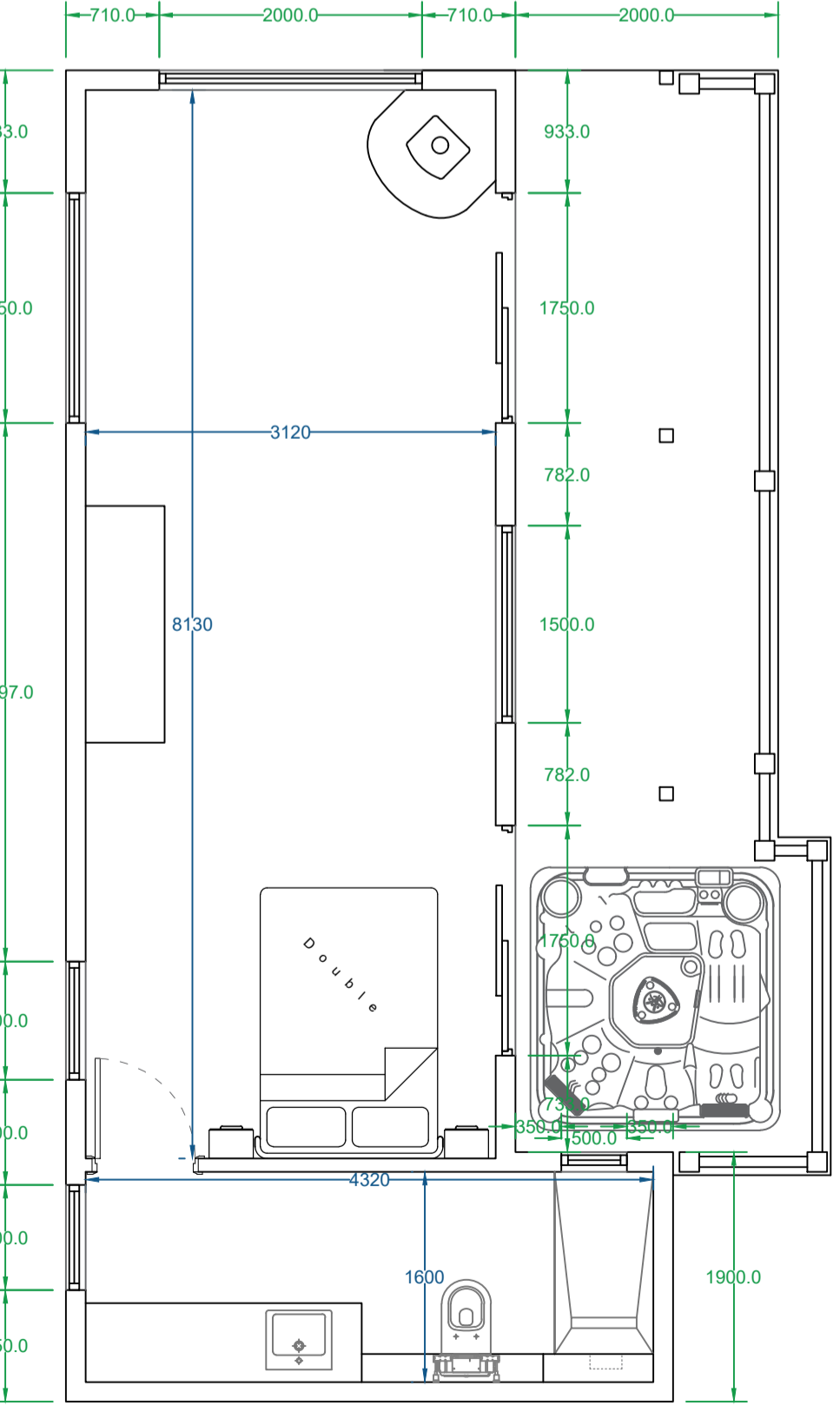


Existing Site Section A-A

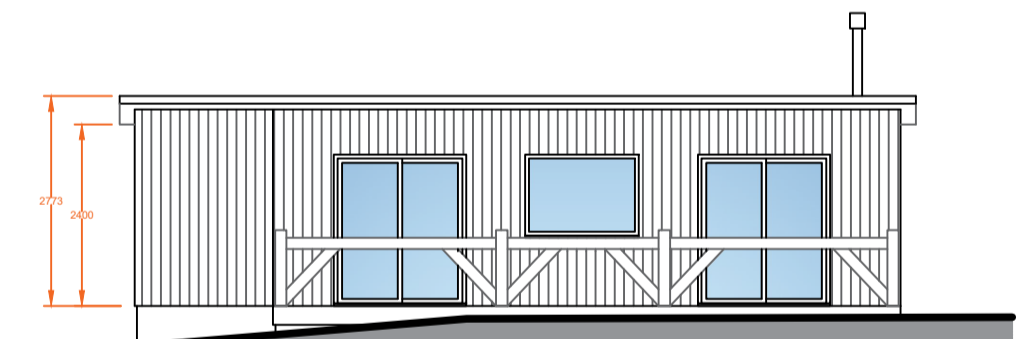


Proposed Site Section A-A

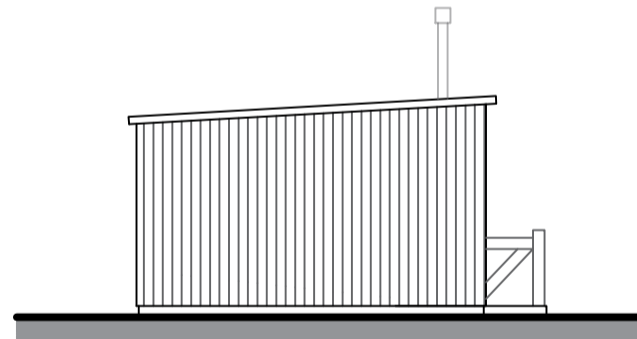

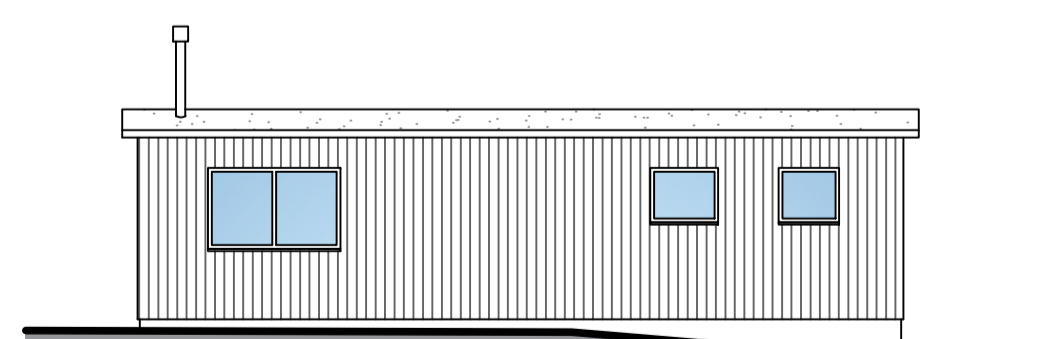
Proposed Ground Floor Plan

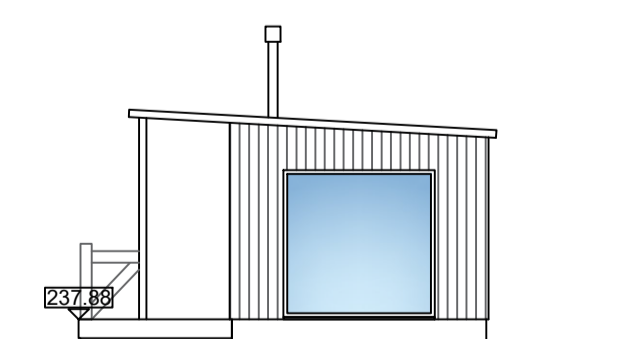
Proposed East Elevation

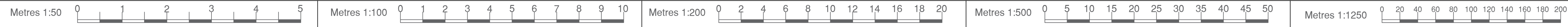


Proposed West Elevation
