Details of the pre-application advice received

If it is not possible to convert the existing garage space, then our preferred option would be a detached outbuilding. Whilst I appreciate the existing uses of the garden, given the substantial plot of land in which the property is sited, it is my view that a small-scale outbuilding could be integrated into the site. This would be less visible from the public highway and would prevent the further elongation of the already linear built form of the property.

Notwithstanding this, if a householder planning application was submitted for the extension to the western gable, then I think it unlikely that the resultant visual impact would be considered significant enough to warrant a refusal in this particular instance.
